**Notice of Public Hearing on Proposed Payment Rates for Medicaid
Community Hospice Effective Retroactive to October 1, 2024, and
Proposed Rate Actions for Employment Readiness Services in the
Deaf-Blind with Multiple Disabilities (DBMD), Home and Community-
Based Services (HCS) and Texas Home Living (TxHmL) Waiver
Programs, Effective January 1, 2025**

SUMMARY OF PROPOSED RATE ACTIONS

This document contains information relating to the proposed rate actions for Federal Fiscal Year 2025 Payment Rates for Medicaid Community Hospice Program, retroactive to October 1, 2024, and Employment Readiness Services in the DBMD, HCS and TxHmL waiver programs, effective January 1, 2025.

Hearing

The Texas Health and Human Services Commission (HHSC) will conduct a public hearing to receive comments regarding proposed payment rates on November 19, 2024, at 9:00 a.m. Central Daylight Time (CDT).

Background

Medicaid Community Hospice Program Services

The Medicaid Community Hospice program provides palliative care consisting of medical, social, and support services to terminally ill individuals when curative treatment is no longer elected. Payment rates for this program are calculated based on annual hospice rates established by the Centers for Medicare & Medicaid Services (CMS). 42 Code of Federal Regulations (CFR) 418.306(c) requires Medicaid hospice payment rates to be adjusted every federal fiscal year by the wage index data issued by CMS as published in the Federal Register. CMS issued notification of the finalized Medicaid hospice payment rates in the Federal Register and published the federal fiscal year 2025 hospice wage indices on September 13, 2024.

Employment Readiness Services

The proposed rates will support new employment readiness services under the DBMD, HCS, and TxHmL waiver programs. HHSC is proposing rates blended across on-site and off-site individualized skills and socialization services. In accordance with House Bill (H.B.) 4169, 88th Legislature, Regular Session, 2023, employment readiness must be fiscally neutral to individualized skills and socialization services.

Methodology

Medicaid Community Hospice Program Services

Payment rates for hospice care are authorized by Section 1814(i)(1)(C)(ii) of the Social Security Act, which outlines annual increases in payment rates for hospice care services. Rates for hospice physician services are not increased under this provision. Section 1814(i)(5)(A)(i) of the Social Security Act requires that beginning with the federal fiscal year 2014 and each subsequent federal fiscal year, the Health and Human Services Secretary shall reduce the market basket update by two percentage points for any hospice provider that does not comply with the quality data submission requirements.

Employment Readiness Services

Payment rates for new employment readiness services are pursuant to H.B. 4169 under the DBMD, HCS, and TxHmL waiver programs.
