SUMMARY OF PROPOSED PAYMENT RATES **Effective August 1, 2021**

The Texas Health and Human Services Commission (HHSC) will conduct a public hearing at 9:00 a.m. on July 14, 2021.

HHSC will consider concerns expressed during the hearing prior to final rate approval. The hearing will be held in compliance with Texas Human Resources Code §32.0282, which requires public notice of and hearings on proposed Medicaid reimbursements.

PROPOSED RATES

HHSC is proposing rates for in-home and out-of-home day habilitation and in-home and out-of-home respite in the Home and Community-based Services Waiver (HCS) program and the Texas Home Living Waiver (TxHmL) program. The HCS and TxHmL rates are proposed to be effective August 1, 2021.

METHODOLOGY AND JUSTIFICATION

The proposed payment rates for these topics are guided by the following section in Title 1 of the Texas Administrative Code: §355.723, related to the Reimbursement Methodology for Home and Community-Based Services and Texas Home Living Programs.

The billing codes for day habilitation and respite in HCS and TxHmL are being modified to comply with Electronic Visit Verification requirements, and the proposed rates follow these modified billing codes.
