Medicaid Community Hospice payment rates are proposed to be effective retroactive to October 1, 2020

Home and Community-Based Services – Adult Mental Health payment rates are proposed to be effective January 1, 2021

SUMMARY OF PROPOSED PAYMENT RATES
Effective Retroactive to October 1, 2020 and Effective January 1, 2021

The Texas Health and Human Services Commission (HHSC) will conduct a public hearing at 9:00 a.m. on November 30, 2020.

Due to the declared state of disaster stemming from COVID-19, this hearing will be conducted online only. HHSC will consider concerns expressed during the hearing prior to final rate approval. The hearing will be held in compliance with Texas Human Resources Code §32.0282, which requires public notice of and hearings on proposed Medicaid reimbursements.

PROPOSED RATES.

HHSC proposes to increase payment rates for Medicaid Community Hospice for routine home, continuous home, inpatient respite, and general inpatient care services, effective retroactive to October 1, 2020. The proposed rates for Medicaid Community Hospice are included on the next page of this document and vary based on county and whether the hospice provider has or has not submitted quality data.

HHSC also proposes to convert the HCBS-AMH daily payment rate of \$238.60 to a 15-minute rate of \$2.49, effective January 1, 2021.

METHODOLOGY AND JUSTIFICATION.

The increased payment rates for Medicaid Community Hospice for routine home, continuous home, inpatient respite, and general inpatient care services were determined in accordance with the hospice reimbursement methodology located in the Code of Federal Regulations, Title 42, Part 418, Subpart G.

The proposed payment rate for HCBS-AMH was developed in compliance with HHSC's established rate methodology in 1 TAC §355.9070 relating to Reimbursement Methodology for Home and Community-Based Services – Adult Mental Health Program. Conversion of the in-home respite rate to 15-minute units is necessary for the implementation of electronic visit verification.
