Notice of Public Hearing on Proposed State Fiscal Year 2024 Interim Reimbursement Rates for Small and Large State-Operated Intermediate Care Facilities for Individuals with an Intellectual Disability (ICFs/IIDs), Effective Retroactive to September 1, 2023.

SUMMARY OF PROPOSED RATE ACTIONS

This document contains information relating to the proposed state fiscal year 2024 Medicaid interim reimbursement rates for Small and Large State-operated Intermediate Care Facilities for Individuals with an Intellectual Disability (ICFs/IIDs). The Texas Health and Human Services Commission (HHSC) is proposing these interim rates to ensure there are adequate funds to serve the individuals in these facilities. The proposed Medicaid interim payment rates are to be effective retroactive to September 1, 2023.

Hearing

HHSC will conduct a public hearing to receive comments on proposed payment rates on April 29, 2024, at 9:00 a.m. Central Daylight Time (CDT).

Background

There are currently thirteen SSLCs and four Bond Homes in operation. All are reimbursed on a statewide uniform interim daily rate per person served. Interim reimbursement rates for SSLCs and Bond Homes are required to allow for the availability of adequate funds to serve individuals residing in these facilities and do not vary by level of need. These amended proposed interim rates account for actual and projected increases in costs to operate these facilities.

Methodology

The proposed payment rates were determined in accordance with Title 1 of the Texas Administrative Code Section 355.456, which addresses the reimbursement methodology for ICFs/IIDs.

Proposed Rate Adjustments

HHSC proposes the following interim per diem reimbursement rates for small and large state-operated ICFs/IIDs to be effective retroactive to September 1, 2023:

Bond Homes – Medicaid-only clients:
Proposed interim daily rate: \$919.74

 Large State-Operated ICFs/IIDs – Medicaid-only clients: Proposed interim daily rate: \$1,305.78

 Large State-Operated ICFs/IIDs – Dual-eligible Medicaid/Medicare clients:

Proposed interim daily rate: \$1,256.51
