SUMMARY OF PROPOSED PAYMENT RATES Effective Retroactive to October 1, 2021

HHSC will consider concerns expressed during the hearing prior to final rate approval. The hearing will be held in compliance with Texas Human Resources Code §32.0282, which requires public notice of and hearings on proposed Medicaid reimbursements.

PROPOSED RATES

HHSC proposes to increase payment rates for Medicaid Community Hospice for routine home, continuous home, inpatient respite, and general inpatient care services, effective retroactive to October 1, 2021.

The proposed payment rates are listed in the attachment outlined below and vary based on county and whether the hospice provider has or has not submitted quality data.
