Notice of Public Hearing on Proposed State Fiscal Year 2024 Interim Reimbursement Rates for the State Veterans Nursing Homes,
Effective Retroactive to September 1, 2023

#### **SUMMARY OF PROPOSED RATE ACTIONS**

This document contains information relating to the proposed state fiscal year 2024 Medicaid interim reimbursement rates for State Veteran Nursing Homes. The Texas Health and Human Services Commission (HHSC) is proposing these interim rates so the facilities will have adequate funds to serve the individuals in these facilities. The proposed Medicaid interim payment rates are to be effective retroactive to September 1, 2023.

#### **Hearing**

HHSC will conduct a public hearing to receive comments on proposed payment rates at 9:00 a.m. (CST) on February 27, 2024.

#### **Background**

HHSC maintains a program so Medicaid-eligible veterans can reside in State Veteran's Nursing Homes. Currently, eight homes are in operation, overseen by the Veterans Land Board (VLB). The VLB is authorized to operate these nursing facilities under Chapter 164, Natural Resources Code. The VLB determines rates for the Texas State Veterans Homes (VLB-determined rates). However, HHSC is responsible for setting the Medicaid rates paid to these homes through our rate-setting process.

#### **Methodology**

The specific administrative rule that govern the establishment of the fees in this proposal were calculated in accordance with Title 1 of the Texas Administrative Code (TAC) Section 355.311, concerning Medicaid Reimbursement Rates for State Veterans Homes.
