Training Reminder #22

RMTS annual training is mandatory for all Early Childhood Intervention (ECI) entities that participate in the Medicaid Administrative Claiming (MAC). Training sessions are conducted by the Texas Health and Human Services Commission (HHSC). Please remember, once an RMTS contact has successfully completed <u>one</u> training for the current fiscal year, they have met the annual requirement.

<u>If you have completed and received training credit in August 2022 – February 2023</u> <u>trainings, you have fulfilled your annual training requirement and will not need to attend</u> <u>any more trainings for the rest of the FFY 2023.</u> Training reminders will continue to be emailed to programs in the event additional staff want to be involved in the process.

It is crucial ECIs understand that compliance with the RMTS annual training requirement is mandatory. Failure to comply with this requirement will impact the ECI's ability to draw federal funding for MAC services provided. In addition, ECI's will not be given full access to the online time study system for FFY 2023 until the annual training requirement is met.

Beginning FFY 2023, Early Childhood Intervention (ECI), Local Health Departments/Districts (LHD) and Mental Health & Intellectual Developmental Disabilities (MH-IDD) will have combined initial and refresher trainings.

"Initial versus Refresher"

Training requirements can be met by one of two methods. RMTS Contacts who have never attended RMTS ECI training <u>must</u> attend "initial" training. Those who have attended an initial training may attend either initial or refresher training. See above website for additional details.
