Notice of Proposed Adjustments to Payment Rates for Rural Hospital Outpatient Services

Adjustments are proposed to be effective September 1, 2023

### SUMMARY OF PROPOSED ADJUSTMENTS

## To Be Effective September 1, 2023

Included in this document is information related to the prospective reimbursement methodology for the outpatient payment of rural hospitals participating in Medicaid. The Texas Health and Human Services Commission (HHSC) intends to submit an amendment to the Texas State Plan for Medical Assistance under Title XIX of the Social Security Act to increase the outpatient reimbursement rates for rural hospitals to reflect these proposed adjustments. The rates are proposed to be effective September 1, 2023.

## <u>Hearing</u>

The Health and Human Services Commission (HHSC) will conduct a public hearing to receive comments regarding the proposed adjustments to Medicaid rates detailed in this document on July 11, 2023, at 9:00 a.m. The hearing will be held in compliance with Texas Human Resources Code §32.0282, which requires public notice of and hearings on proposed Medicaid reimbursements.

### **Background**

HHSC is required by House Bill 1 (H.B. 1), Article II, Rider 8(c), 88th Legislature, Regular Session 2023 to allocate certain funds appropriated to provide an increase to outpatient reimbursement rates for rural hospitals. HHSC proposes an increase to outpatient services reimbursement applying a percentage increase to the cost to charge ratios for rural hospitals.

### Methodology

The specific administrative rule that govern the establishment of the rates in this proposal include this rule in 1TAC:

• Section 355.8061 – Outpatient Hospital Reimbursement

### **Proposed Rate Adjustments**

Increase outpatient services reimbursement by applying a percent increase to the cost to charge ratio in effect on August 31, 2023.

# **Potential Testimony Limitations**
